WBI Energy Transmission, Inc. (WBI Energy), herewith submits supplemental information in the above referenced dockets to assist Federal Energy Regulatory Commission (FERC or Commission) staff in the preparation of the environmental assessment for the North Bakken Expansion Project (Project).

On September 11, 2020, WBI Energy filed supplemental Project information which included several proposed minor route variations reflected in Table 10.6.3-1 of Resource Report 10 since the submittal of WBI Energy's February 14, 2020 Application. These minor route variations were also depicted on a Project map set filed on October 5, 2020 in response to FERC's September 25, 2020 environmental information request. The Project map set was included as General Request No. 1 Attachment – Project Map Set Depicting Alignment and Workspace Changes Between the February 14, 2020 FERC Application and September 11, 2020 Supplemental Filing (“**CUI//PRIV – DO NOT RELEASE**”).

No new landowners will be affected by any of the minor route variations. WBI Energy contacted those landowners associated with a minor route variation where additional survey work was required to discuss the route variation and obtain survey permission. WBI Energy will discuss minor route variations that did not require additional survey work with the affected landowners during the easement negotiation process currently underway.
