WBI Energy Transmission, Inc. (WBI Energy), herein submits a response to a request of the Federal Energy Regulatory Commission (Commission) staff received on October 8, 2020, in the above referenced dockets regarding turn-back capacity associated with the open season held for its North Bakken Expansion Project.

From June 4, 2018 through July 31, 2018, WBI Energy conducted a binding open season for the sale of long term, firm natural gas transportation capacity for deliveries to Northern Border Pipeline in northwest North Dakota. As part of the binding open season, WBI Energy solicited offers from its shippers who held firm transportation capacity with a receipt location on WBI Energy's Line Section 7, 25 or 30 and with an expiration date within the 4th quarter of 2021, or beyond, to notify WBI Energy if they wished to permanently release their capacity in lieu of the construction of additional capacity associated with the open season. WBI Energy did not receive any offers to turn back capacity in response to this solicitation.
