WBI Energy Transmission, Inc. (WBI Energy), herewith submits supplemental information in the above referenced dockets. The information submitted includes updates to the Cultural Resources Survey Report prepared by Beaver Creek Archaeology, Inc. (Attachment A-2) to document field conditions for proposed Level 2 variance requests for the North Bakken Expansion Project (Project) and the concurrence received from the State Historical Society of North Dakota (SHSND) regarding four variance requests (Attachment A-1) for access road reroutes, drilling waste disposal areas and workspace for a layflat water line.

This filing also includes a letter to the SHSND concerning a proposed Level 2 variance request for a minor adjustment to the Project (Attachment B-2) and the SHSND's concurrence letter (Attachment B-1).

The SHSND concurred with a determination of "No Historic Properties Affected" for the five variance requests provided the variances take place in the locations and in the manner described in the documentation.

Pursuant to 18 CFR § 388.112, and consistent with the Commission's precedent and other applicable regulations with respect to sensitive information, WBI Energy requests privileged and confidential treatment of this information, which is labeled "CUI//PRIV – DO NOT RELEASE."
