# INTRODUCTION

By letter order dated September 27, 2021, WBI Energy Transmission, Inc. (WBI Energy) was granted approval by the Federal Energy Regulatory Commission (FERC or the Commission) to utilize the Commission's Pre-filing Review Process for the proposed Wahpeton Expansion Project (Project). The Project will consist of:

- approximately 58.7 miles of 12-inch-diameter natural gas pipeline from WBI Energy's existing Mapleton Compressor Station near Mapleton, North Dakota, to a new delivery station near Wahpeton, North Dakota;
- minor modifications at the Mapleton Compressor Station to interconnect the new pipeline;
- a new delivery station near Kindred, North Dakota; and
- new block valve settings, and new pig launcher/receiver settings.

The Project, as proposed, will allow WBI Energy to add approximately 20.6 million cubic feet per day of natural gas transportation capacity to help meet a growing demand for natural gas in southeastern North Dakota. The Project has been assigned Docket No. PF21-04-000.

This Monthly Progress Report provides a brief summary of significant Project activities or changes in Project information that have occurred during the period beginning November 1, 2021 through November 30, 2021.

## FIELD SURVEYS

- Survey access has been obtained for approximately 95 percent of the pipeline route.
- Approximately 95 percent of the biological and cultural surveys have been completed based on the current route.
- Surveys have concluded for the 2021 field season.
- Follow-up on a few parcels and any reroutes is targeted for spring 2022, dependent on weather conditions and potential reroutes.

## **RESOURCE REPORTS**

- FERC selected Cardno, Inc. as its Third-Party Contractor to assist FERC in developing a National Environmental Policy Act document.
- FERC provided comments on the preliminary drafts of Resource Report 1 (General Project Description) and Resource Report 10 (Alternatives).
- WBI Energy continued to work on draft resource reports.

## AGENCY/TRIBAL CONTACTS

• Between November 1 and November 29, 2021, WBI Energy sent multiple e-mails to and held a conference call with the Northern Arapaho Tribal Historic Preservation Officer regarding, potential sites within the Area of Potential Effect, already adopted reroutes to



avoid a cultural site, clarification on the letter of effects that Northern Arapaho sent, survey participation/report access, and lack of presence of stone feature sites during surveys.

- On November 18, 2021 submitted information to the Federal Aviation Administration to conduct an aeronautical study to make a hazard determination regarding the potential site of the Kindred Border Station.
- WBI Energy made plans to follow-up on its initial agency contacts.

## **STAKEHOLDER ACTIVITIES**

- On November 2, 2021, mailed a letter to new landowners providing information about the Project, next steps in the process, and invitation to WBI Energy's public open houses on November 16 and 17, 2021.
- Held four public open house meetings, two in Kindred, North Dakota on November 16, 2021 from 11:00 am to 1:30 pm and 4:30 pm to 7:00 pm, and two in Wahpeton, North Dakota on November 17, 2021 from 11:00 am to 1:30 pm and 4:30 pm to 7:00 pm.
